Laboratories are of 2 or 3 ECTS. Each ECTS includes 25 hours of learning, organised as follows:

- 15 hours of distance learning and personal studying;
- 10 hours of specialised class activity under professional supervision.

The laboratories are recognised for the internship under the EuroPsy accreditation scheme, and consist of *Highly Specialised (HS)* and *Interdisciplinary (IT)* labs.
